DEMOCRATIC WOMEN OF ERIE COUNTY STANDING RULES

- 1. Membership dues shall be: Regular \$15.00, Senior (62 and over) \$10.00 and Associate (men) \$15.00.
- 2. The Treasurer shall disburse a donation of \$40.00 to deceased member's favorite charity.
- 3. All officers, on expiration of their elected/appointed term, shall deliver records, papers, or property of the organization to their successor in office.
- 4. All special events/dinners shall be the 3rd Monday of the month.
- 5. Any cancellations of special events/dinners shall be approved by the membership with a majority vote of members present.
- 6. Members will not be billed for regular monthly meeting reservations when cancelled at least twenty-four (24) hours prior to the meeting.
- 7. Only elected officers and appointed committee chairs are authorized to make expenditures for our organization.
 - (a.) All expenditures in excess of \$50.00 shall be pre-approved by the Executive Board.
 - (b.) Members-at-Large may make purchases only by authorization of the Executive Board
 - (c.) Exception shall be postage stamps for mailings.
- 8. All monies collected for the organization shall be given to the Treasurer and shall not be used to purchase supplies.
- 9. All receipts shall have date, name, event and amount for reimbursement from the Treasurer.
- 10. The Dorothy Deering Scholarship as well as other scholarships will be awarded yearly and the amount determined by the Executive Board, with membership approval.
- 11. Any Democratic Candidate running in a partisan election as a Democratic, in good standing with the Democratic Party may receive a donation from the Democratic Women of Erie County ("DWEC").
 - (a.) Candidate must be opposed and donation shall be for the General Election.
 - (b.) The DWEC's checking account balance shall be \$1,500.00. (including outstanding checks) before monies can be donated to a Democratic candidate.
 - (c.) The donation given to each candidate will depend on the number of Democratic candidates running in the General Election and is subject to membership approval.
- 12. Any member of the DWEC who is a candidate for a non-partisan election, in good standing with the Democratic Party may receive a donation from the DWEC.
 - (a.) Candidate must be opposed and donation shall be for the General Election.
 - (b.) The DWEC's checking account balance shall be \$1,500.00 (including outstanding checks) before monies can be donated to a Democratic candidate running for a nonpartisan office.
 - (c.) The donation given to each candidate will depend on the number of members of the DWEC running for nonpartisan offices in the General Election and is subject to membership approval.
- 13. The Christmas Committee shall be allotted \$100.00 for needed supplies.
- 14. All issues to be reviewed by the membership shall be circulated in writing seven days before the meeting at which such issues are to be voted upon by the membership.
